## **OPERATING INSTRUCTIONS**

### **ROCK & ROLL**

**DO NOT OPERATE THE KINDAS' UNIT IN WINDY OR UNFAVORABLE WEATHER CONDITIONS. KINDAS' JUMPS CAN TURN OVER BY HIGH WINDS SEVERELY INJURING OCCUPANTS.**

Make sure that the **KINDAS' UNIT** is fully inflated before using it. Never allow riders on a partially inflated unit. All riders must remove their shoes and empty their pockets of any hard objects that can injure themselves or others while playing in the unit. Eyeglasses and jewelry should also be removed. This includes watches, bracelets, necklaces, etc...

**Riders should all be of the same age group** and should be limit to the maximum numbers of riders shown below. Never allow more riders in the unit than is shown. A competent adult must supervise the unit at all times.

In the event of severe weather, remove all riders from the unit and unplug immediately. Make sure the unit remains securely anchored. Do not reinflate unit until adverse weather conditions cease. When conditions permit, inflate unit and allow it to dry before using again. Never allow playing on a wet unit.

If the **KINDAS'** inflatable becomes unplugged or losses power during the operation, the attendant should remove players from the unit. There is no cause for alarm, riders should be told to remain calm and follow the attendant's instructions.

**GENERAL RULES FOR SAFE OPERATION**

- A. **2 JOUST POLES AND 2 SET OF BOXING GLOVES ISSUE ( FULL CHARGE PRICE WILL APPLY IF EQUIPMENT DESTROYED)** \_\_\_\_\_
- B. **NO PLAYING AROUND UNIT. STAY 10 FEETS AWAY (I.E. BLOWERS, STICKS, ETC)** \_\_\_\_\_
- C. **NO FLIPS, NO ROUGH PLAY** \_\_\_\_\_
- D. **NO SHOES OR SHARPS OBJECTS IN OR AROUND THE INFLATABLE** \_\_\_\_\_
- E. **NO FOOD, DRINKS OR GUM IN OR AROUND THE INFLATALBE (\$25.00)** \_\_\_\_\_
- F. **MUST BE SUPERVISED AT ALL TIMES** \_\_\_\_\_

There will be a charge of \$50.00 for the cleaning of the inflatable and Lessee understand that he or she will be responsible for any repair damage.*
